## THEN I TRIED AA

Why is AA supreme in rehabilitating alcoholics, when so many other methods fail? For fifteen years I struggled to learn how to drink liquor without getting into trouble, and I failed...but now I know several reasons in answer to that question. Fifteen years ago, I knew I had an alcoholic problem. I did not actually accept the fact, but knew that something should be done about it. My wife and relations, my boss, the neighbors—all were becoming standoffish. Occasionally they flared up over my repeated benders and binges, making my life more miserable with nagging, scolding and the silent treatment. Something should be done, all right. But what? I tried the wagon. After about four weeks of sobriety, I could not eliminate the unbearable obsession to drink from my mind so I tried another solution—talking with a minister. He was very kind and understanding, and suggested that it might help if I joined his church and “got in with the right-thinking and right-living people.” He prayed for me and with me, and I left assured. I joined the church and even was baptized. The treatment worked—for two whole months. Then came the worst drunk I had ever been on, more trouble than I had ever been in, and I ended up in jail this time. I left the church in disgrace, feeling more like a sinner and failure than ever before. I tried another treatment—consulting the doctors. They helped me get off drunks and gave me repeated warnings to stop drinking and to get off to the simple fact that I couldn’t drink. The result? I lost confidence in the doctors and myself—and found myself in the alcoholic wards of hospitals three additional times. Next, I managed to swing the price of a psychiatrist. Every day for sixteen straight months I went to him for analysis. He delved into my past and found out a great many very interesting things. But help me out of my alcoholic problem? When I left him I was in a huff, feeling like a mental case, wishing I was one, and I *was drunk*. Three methods tried, three methods failed. Hopelessly I progressed alcoholically right down the line....three years of disaster drinking, flop-houses, failure even at holding down a dishwashing job. My wife left me in desperation seven different times. I lost houses full of furniture three different times. Steadily, I lost confidence, faith and hope. Then I tried AA. Even there I floundered for a while, but then I got the drift and stayed sober. And now I know why AA made my life manageable when every other method failed! Why couldn’t even my family, the clergy and the doctors help, even though they tried very hard? I believe that they actually did not know how to accomplish the result they sought so hard. My family could help me in everyday matters. A clergyman could help me solve my religious problems. The doctors and psychiatrists could treat my physical and mental ills. But none of them was equipped to help the alcoholic when needed, because they lacked the studied knowledge of the many-sided alcoholic problem, which cuts across so many fields. This is by no means any fault of theirs—but they simply in most cases have not been trained to understand the many and complex factors involved in the treatment and rehabilitation of alcoholics. And the vast majority can find no time to give special study to the alcoholic disease along with all the other things they must do to keep up with their regular professional life. It had been nine months since I took my last drink, and I have seen many wonderful changes take place during this short period. The other night I was sitting in the back row of our group meeting place, enjoying an interesting AA program, when the chairman unexpectedly called on me to tell how AA had helped me. As I slowly proceeded to the speaker’s stand, I tried to collect my thoughts, and many instances of the good AA does came to my mind. For example: Nine months ago I had a wife who was intolerant, nagging, critical, and extremely difficult to live with. She has been attending AA meetings with me, and has become well informed about the AA program. The things she has learned in AA have had a remarkable effect on her a she has been transformed into a tolerant, pleasant, agreeable and helpful person. Nine months ago I had a mother-in-law who was stupid, meddlesome, and a definite trouble maker. I have carefully explained the AA program to her, and as a result of the knowledge I have imparted to her, she has become a sweet, loving, understanding little lady. Nine months ago I had a mother who was a most disturbing and upsetting influence in my life. She has read and studied the AA program, and it made such an impression on her that her visits to our home are now pleasant events, since she contributes so much to the serenity and happiness of our life. Nine months ago I had three boys who were holy terrors, and were enough to drive any man to drink. Naturally they have heard much about the AA program, and while they are quite young, even they have been able to understand enough about it to adopt an entirely new attitude toward their responsibilities. Nine months ago I had neighbors who were complaining, gossiping, unfriendly people. My mother-in-law, who lives with us, maintained friendly relations with our neighbors, even though they were a bunch of stinkers. Through her, my neighbors have learned something about the AA program, and the information they have acquired, even though on a third hand basis, has been enough to change them into considerate, helpful, friendly people, anxious to see me succeed. Nine months ago I had an employer who had absolutely no faith in humanity and trusted and believed in no one. I have taken the pains to fully acquaint him with the AA way of life, for which he should certainly be grateful, as he is doing better in every way as shown by the complete confidence and trust he now shows towards people. Nine months ago I had a car which wouldn’t drive straight or stop quickly. Some people contend that the mind has power over matter, and I believe this, because while driving I have mulled over many ideas about the AA program, and these ideas have had their effect on my car, which now operates as a proper vehicle should. Nine months ago many simple minded people were flocking to the churches where they were being misled by ignorant preachers who were determined to scare Hell out of them in order to extract some of their hard earned dough from them. But the ministers have rapidly become familiar with the AA program, and as a result have really become dedicated people. The wisdom and knowledge they are now pouring forth to their congregations is quickly taking hold. Nine months ago my

Mike B. opened the April 16, 2022, TBAIC Zoom meeting with the Declaration of Unity. Attendees: Mike B., Rich R., Sara R., Scott S., Tom F., Jason C., John O., Jeremy G., Aaron M., Hezekiah D., and John T. Aaron M. mentioned that this was his first committee meeting. Aaron recently volunteered to chair a meeting at ACTS Detox and on the Bridging the Gap call list. Mike B. presented the chair report. Mike said he attended the recent quarterly area meeting in Boca Raton. He said he attended the corrections and treatment committee workshops. The area delegate attended the corrections workshop and Mike mentioned to the delegate that while there were many changes to literature being considered by the General Service Conference, he had not heard much talk about the changes at meetings he attended. The delegate urged Mike to spread the word and encourage members to participate in district and area level service work. Mike also said review of the corrections workbook was completed and results will be sent out with these minutes. Mike said he was unable to attend the April district meeting, but he did a presentation about TBAIC at the Old School Group service workshop in March and as a result several individuals expressed interest in volunteering for TBAIC work. John T. asked if there were any questions or comments regarding the March minutes. Nothing was mentioned. The minutes were approved. Scott S. presented the treasurer's report. The current Pink Can balance is \$11,038.38. Contributions for the month totaled \$901.29. Operating expenses were \$262 and literature purchases costs totaled \$942.62. The report was approved. INSTITUTION MEETINGS UPDATES Treatment facilities meetings:  ACTS Amethyst – John T. said volunteers have committed to chair 12 live and 1 Zoom meeting per week. The only meeting without a chair is the Thursday 1pm meeting.  ACTS Detox – John said volunteers have committed to chair 6 evening meetings and 1 daytime meeting per week. Chairpersons are still needed for noon time meetings on all days except Thursday.  ACTS Sandra Prince Intermediate Care Program – John said there are now two facilities – one on 17th St and one on 131st Ave. John said a volunteer has committed his home group to chair the meeting at one of the facilities, but another volunteer is needed for the other facility. John said the meeting start date is to be determined.  Cove Behavioral Health (formerly DACCO). Both men's and women's meetings have restarted. The same volunteers who chaired meetings prior to shutdown have agreed to again chair meetings.  HCA Florida West Tampa Hospital (formerly Tampa Community Hospital). Point of contact had mentioned in October that meetings at their detox could be restarted. John contacted her and was told the new ownership of the hospital is now requiring all visitors undergo an extensive background review similar to an employment application. The point of contact said that the population of their detox has been low, and it would not be worth our time to have meetings there at this time.  North Tampa Behavioral Health – John said he spoke with Kevin B. who had been chairing meetings there until Covid-19 shutdown. John said Kevin told him the new management of the hospital was requiring an extensive background review for all visitors. He said the facility is still closed to visitors due to Covid-19.  White Sands of Brandon – John said he received an e-mail via central office from a representative of the facility requesting AA meetings be held there. John said he called twice and left messages and followed that up with e-mail but no response received. No further action will be taken until someone from the facility contacts us.  Riverside Recovery – John O. said meetings have been going for about 2 months. Attendance has been good enough to start holding meetings every week rather than every other week. John added that management of Riverside had planned to attend this committee meeting, but other activities prevented them from doing so.  River Oaks – Jason C. said meetings are going well 3 days a week – Monday, Wednesday, and Friday. He said NA meetings are no longer being held on Tuesday and Thursday which could result in more AA meetings. He added that the temporary sponsor meeting idea seems to be working well. He said River Oaks now requires all patients to have a temporary sponsor. Corrections facilities meetings:  TruCore Behavioral Solutions – Jason C. said 5 female volunteers have applications being processed and should be ready to start meetings in May.  Falkenburg Road Men's Jail – Rich R. said Sunday morning and Saturday afternoon meetings are going well. He said a third person has been worked into the Sunday morning rotation which will allow him and Michael to take time off during May.  Falkenburg Road Women's Jail – Sara R. meetings are being held on Sunday afternoon. She said 2 new volunteers have submitted applications and once they have been approved, they will likely be able to add a meeting on Mondays.  Zephyrhills Correctional Institute – Tom F. said meetings are going well. He said they are slowly going through the Big Book. He said he recently purchased several Big Book dictionaries which should help in that process. Bridging the Gap – John T. read report from Tracy S. as follows: "Ring central March activity 3 calls, 2 messages left, third routed to Carol on list to arrange. Waiting to hear back from her on the status." John T. said he had

received calls from 3 people and was able to connect 2 of the 3 callers with members on the call list who took the individuals to a meeting. Efforts to connect with the 3rd caller were not successful since the call back number was not in service. John O. said he had received a group text message which included Hezekiah D. and several others. John O. said he was able to get that individual to a meeting. Man on the Bed – Tom F. said he received 3 calls. He said he contacted all 3 individuals. Two were not interested in going to meetings. The other individual was interested in meetings and Tom said he gave him meeting information. OLD BUSINESS: Mike B. brought up the issue related to using the same Bridging the Gap business cards for both treatment and corrections facilities. Tom F. explained the AA Pre-release program is designed more for long term offenders. He said that would apply to individuals being released from prison. However, he said the Bridging the Gap program would be applicable to individuals in jails since their terms are usually less than 1 year. Tom felt like using the same card in treatment centers and jails would be appropriate. Sara R. expressed reservations with doing that since individuals on call list may not be willing to contact individuals released from jails. The consensus was that the same card be used. NEW BUSINESS: Jeremy G. asked whether groups should continue to pass the Pink Can considering the current Pink Can balance. John T. said he had received an email a few days ago from someone in another group who asked the same question. John said he coordinated his response with Mike B. and Scott S. He said his response was that the committee did talk about that several months ago but did not ever say groups should not pass the Pink Can since the decision to do so is the group's decision. John added that he looked in the TBAIC literature cabinets at the central office earlier this week and much of the stock has been depleted which means the Pink Can funds will soon be used to replenish the literature. Scott S. indicated he would use Pink Can funds to fill the cabinet with the list of previously approved literature items. John T. mentioned that several Bridging the Gap callers have given call back numbers for the institutions where they are located. When calling back, it was not possible to contact the individual or to leave a message. Mike B. said we should ask callers to give a call back number where we can contact them directly. John T. said he would send an email to volunteers asking them to include that information when mentioning the program at meetings. John T. also said he would discuss with managers at treatment centers to see if there is something they can do to facilitate the call back process. Sara R. asked to purchase 2 cases of soft cover Big Books for the Falkenburg Road Women's Jail. She said she preferred those over the pocket-sized Big Books since the print size was larger and also because they included the stories which are not in the pocket-sized books. After much discussion, the consensus was to approve the purchase. Meeting adjourned with the Responsibility Statement and the Lord's Prayer. The next TBAIC meeting will be Saturday, May 14th, at 9:30 AM via Zoom.



**My Drinking Was My Own Business. Sure It Was! Yet, Certain People Began To Annoy Me, When It Became My Only Business

**STEP 5**

In the first Step, we understood the problem; we were looking for the truth, the true nature of the problem. Once we saw it, we came to believe in a Power greater than ourselves that would restore us to sanity, and that is the truth. In other words, we came to believe that truth exists. In Step 3, we made a decision to turn our lives over to the care of that truth. In order to act on that decision, we needed to find out what was blocking us from the truth, and we did that in Step 4. The fifth Step is a further search for the same thing. In Step 5, we examine the information we found in Step 4 and make sure it is the truth. Step 5 is an evaluation of the inventory in an attempt to get a better look at the information we gathered in the inventory process. Why is this "improving on" Step 4's truth necessary? If an individual has had a problem for weeks, months, or even years, and didn't know he had a problem, it's pretty obvious he is not an expert on the truth! After going through the first four Steps, we don't rely on the information as *we see it*. We don't have a good record of the truth. No one individual really knows the truth anyway—only God knows the truth. We human beings only have our perception of the truth. We can see now that before Step 1 our perception of the truth was very much distorted. Thus we don't want to rely on our limited, perhaps distorted, opinion of what we found in the inventory. Step 5 is getting an outside viewpoint, a different look at things, from God, ourselves, and others. It is interesting and not by chance that Step 5 is laid out in this way. The center of our lives is spiritual—our God—so the first thing we have to do is talk things over with God. The second dimension of our lives is ourselves—our minds—and so we look at things in this way. The third dimension is other people; therefore, finally, we talk with another person. As we go through this, we talk to God about it. Even at this point we'll begin to get new insights. In the process of the Steps, we are trying to get to this consciousness with God. So we begin Step 5 by talking with God. Next we re-examine these things ourselves, and begin to see things we couldn't see before. The final part of the process, then, is to talk with another human being about it. We tell someone else who is not involved, not emotionally involved, in our lives. In most cases, he or she can easily see the real truth of the situation.

**Secretary Report:** Tim read the March Secretary report. Motion to approve & seconded & accepted.

**Treasurers Report:** Tim presented the March Treasurer’s Report. Contributions in March totaled \$ 5,902.08. This accounts for what 43 Groups or Individuals in our area have contributed in March. Included \$ 38.00 from 1 member for the Birthday Club, \$100.00 In Loving Memory of Coffee John and \$ 700.00 for Gene S. Also \$21.00 for Newsletter subscriptions. Our literature sales for March was \$ 6,384.66. This includes sales from A.A. material and non-A,A, material (medallions—etc.) Our total income for March was \$ 12,286.74. Our Total Cost of Goods Sold was \$ 4,436.89. Subtracting the Total Cost of Goods Sold from our March income left us with a Gross Profit of \$ 7,849.85. Our Total Expenses for March were \$ 9,992.65. Subtracting our Expenses from our Gross Profit gave us a Net Income of minus-\$ 2,142.80 for the month of March.

**Old Business:** Al spoke to the discussion from the February meeting about whether we should do live meetings or continue with Zoom. Tim explained that he had done a survey of the Board & Council members on our email list. Out of 75 members, only 18 responded. Tim’s consensus was that most preferred Hybrid/Zoom meetings, therefore we might as well stay on Zoom. Al asked how the Board feels. Discussion followed. Tom felt that if we go back to live meetings, it may be a bonus for us as far as literature sales go, also we may be able to get the word out better concerning our 12 Step call list. Brian noted that the recent Quarterly was all live. It was very good. Linda did not want to drive at night and was still concerned about Covid. Anthony felt that since the meeting is so short, was it worth it to come in. Linda mentioned the gas prices that we are currently experiencing. © Today in April of 2022 COVID has changed the way many groups contribute to the Central Office. Some groups have remained steady in their contributions, some groups have gone to ZOOM, A few ZOOM groups have made some contributions and some groups are Hybrid (in-person & ZOOM), other groups have folded for a lack of a space to have their meeting and some new groups are starting up, and now many groups are getting back to normal pre-pandemic live meetings. Things are looking up and getting better. It's certainly a time to renew our efforts and practice the meaning of the Serenity Prayer a little bit more. We currently have around 210 Groups in the Hillsborough-East Pasco area with around 524 meetings weekly. Contributions in April totaled \$ 11,925.40. This accounts for what 61 Groups or Individuals in our area have contributed in April. Included \$ 263.00 from 3 members for the Birthday Club, \$100.00 from the Sobersticks Event. Our literature sales for April was \$ 67,543.82. This includes sales from A.A. material and non-A.A. material (medallions—etc.) Our total income for April was \$ 19,479.57. Our Total Cost of Goods Sold was \$ 5,654.22. Subtracting the Total Cost of Goods Sold from our April income left us with a Gross Profit of \$ 13,825.35. Our Total Expenses for April were \$ 8,770.88. Subtracting our Expenses from our Gross Profit gave us a Net Income of plus +\$ 5,054.47 for the month of April. I have to express my Gratitude to not only to the A.A. Groups in our area who continue to support us, but also to those Anonymous A.A. members who generously give, I believe, from the Heart ( and I know who many of you are) to support the Central Office. We still have a good Prudent Reserve, all our bills keep getting paid, the lights are on, we have a decent amount of literature available, the phones are working and it looks like 2022 just might be a better year to look forward to.
